Key Points

- 3805 potential victims were submitted to the National Referral Mechanism in 2016; a 17% increase on 2015.
- Reporting showed potential victims of trafficking from 108 different nationalities in 2016.
- Albanian, UK and Vietnamese nationals are the most commonly reported potential victims.
- The most common exploitation type recorded for potential victims exploited as an adult was labour exploitation, which also includes criminal exploitation.
- The most prominent exploitation type recorded for potential victims first exploited as a minor was labour exploitation, which includes the sub category of criminal exploitation, such as cannabis cultivation.
- Of the 3805 potential victims referred to the NRM in 2016, 150 were from Scotland, 123 from Wales and 33 from Northern Ireland. The remaining 3499 were referred from England.
- Minor exploitation referrals in the UK increased 30% to 1278 in 2016, compared to 982 in 2015.

National Referral Mechanism Statistics - End of Year Summary 2016

This report presents a summary of the number of potential victims of modern slavery referred in to the National Referral Mechanism (NRM) in 2016.

The figures used are from NRM data with a cut-off date of **06/01/2017**. Some of the cases remain open with the Competent Authorities and decisions on their trafficking status are yet to be made. The NRM is a 'living' process and data should be considered provisional until all cases are concluded. Some values may differ from previous or future reports as supplementary information is revealed throughout the duration of a case and their records are adjusted accordingly.

This report does not provide any analysis of the picture of modern slavery in the UK. It provides figures relating to the number of potential victims that have been referred in to the NRM process during 2016.

Decision data

This report contains limited decision data for 2016, as a considerable proportion of cases (over 55%) are pending a final outcome.

A summary of the current status¹ for cases between 2013 to 2016 is provided to give an indication of the proportion of cases that may receive a positive or negative outcome.

NRM Statistics 2016

In 2016, the NRM received 3805 referrals of potential victims (PV); this represents a 17% increase on 2015 referral totals. Reportedly, the PVs originated from 108 countries; this represents a 5% increase on 2015 country of origin totals.

The 3805 referrals comprised 1936 females (51%) and 1864 males (48%), with 5 (<1%) recorded as transgender. 2527 (66%) were referred for adult exploitation categories and 1278 (34%) referred for exploitation as a minor. Minor exploitation referrals increased 30% on 2015 totals.

Annex A - ENGLAND - 2016

In 2016 the UK National Referral Mechanism (NRM) received 3499 referrals of potential victims (PV) where the first responder was based in England; this represents a 19.2% increase on the 2015 figure and accounts for 92% of all UK referrals to the NRM.
